Product Description:

The non-structural protein 6 (nsp6) gene from severe acute respiratory syndrome-related coronavirus 2 (SARS-CoV-2), Wuhan-Hu-1 (GenBank: [MN908947](#)) was codon optimized, tagged with a tobacco etch virus (TEV) cleavable N-terminal hexa-histidine tag and cloned into the [pET-28a\(+\)](#) plasmid.^{1,2} The kanamycin resistance gene, *aph*, provides transformant selection through kanamycin resistance in *Escherichia coli* (*E. coli*). The resulting size of the plasmid is approximately 6180 base pairs. The complete plasmid sequence and map are provided on the BEI Resources webpage. The plasmid was produced in *E. coli* and extracted.

NSP6 is located within the SARS-CoV-2 ORF1ab polyprotein. Together with NSP3 and NSP4, NSP6 induces the formation of double-membrane vesicles, which are critical structures required for viral replication.³

Material Provided:

Each vial contains plasmid DNA in TE buffer (10 mM Tris-HCl, 1 mM EDTA, pH 8.0). The DNA concentration and volume provided are shown on the Certificate of Analysis. The vial should be centrifuged prior to opening. Note: The contents of the vial should be used to replicate the plasmid in *E. coli* prior to expression studies.

Packaging/Storage:

NR-53498 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and

should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
